

Summer Singers Camp Financial Aid Policy and Application Protocol

Northwest Choirs is committed to providing access to all young singers, regardless of financial background.

1. Eligibility Criteria

- Financial aid is available to families demonstrating financial need.

2. Application Process

a. Application Form

Parents or guardians must complete the Northwest Choirs Financial Aid Application Form which includes:

- Household income and expenses
- Number of dependents
- Employment status
- Optional statement of financial hardship

b. Required Documentation

Please submit the following with your application:

- Most recent federal tax return-only 1st two pages or two recent pay stubs
- Documentation of government assistance (if applicable)
- Optional personal letter explaining circumstances

c. How to Submit

- Completed applications must be submitted by June 1, 2025 or before registration deadline.
- Submit forms via email to financialaid@northwestchoirs.org, or in person at the Northwest Choirs office.

3. Review & Notification

- All applications will be reviewed by the Northwest Choirs Financial Aid Committee.
- Decisions are based on financial need and the availability of scholarship funds.
- Notifications will be sent within two weeks of the application deadline.
- All information submitted is kept confidential.

4. Award Structure

- Awards may cover between 10% and 90% of eligible program fees, \$100 is non-refundable after Financial Aid on the balance is awarded. With financial aid the payment for camp will be between \$140 & \$450

5. Expectations for Aid Recipients

- Students must maintain consistent attendance and active participation.
- Families receiving aid may be asked to volunteer at events or support choir activities.
- Financial aid must be reapplied for annually.

6. Appeals Process

If an application is denied, families may submit a written appeal within 10 days, detailing any additional financial challenges or circumstances.

7. Confidentiality

All financial aid applications are reviewed with strict confidence and handled with sensitivity and respect.
